## First report of ENSREG, as adopted in July 2009

As a matter of fact, there are 148 nuclear power reactors operating in 15 European Union (EU) Member States, producing one third of all electrical energy. Some units have already been decommissioned or are in the process of decommissioning, many are undergoing substantial preparations for long-term operation and several new units are under construction or seriously planned. In addition, there is a substantial number of other nuclear and radioactive waste management installations within the European Union. This situation
