### **EU international assistance work on nuclear safety**

For many years, the EU has provided financial and human resources to help improve nuclear safety in countries outside the EU. This has focused mainly on the countries of Central and Eastern Europe and on the Former Soviet Union. The TACIS instrument that facilitated assistance to the former Soviet Union, and the PHARE nuclear safety programme which included many countries that are now EU Member States, came to an end in 2006, although some residual work is still under way.
