

## Cyprus

### **Nuclear regulatory authority**

The Radiation Inspection and Control Service, Department of Labour Inspection, Ministry of Labour and Social Insurance is responsible for radiation protection, nuclear safety and waste management.

### **Nuclear activities**

There are no nuclear power plants, no research reactors, no waste management facilities, and no uranium mining and milling activities. Radioactive sources are used for medical, industrial and research purposes, and radioactive sources/materials are transported.

### **Radioactive waste and spent fuel management**

No production of spent fuel in Cyprus. Small amounts of radioactive waste are produced from nuclear medicine and research activities.
