

## ENSREG STAKEHOLDER ENGAGEMENT PLAN

## TOPICAL PEER REVIEW ON AGEING MANAGEMENT OF NUCLEAR POWER PLANTS

### Background

One of the key objectives of ENSREG is to improve the overall transparency of issues relating to the safety of nuclear installations and effective radioactive waste management. Pursuant to the Section 5 "Stakeholder engagement and consultation" of the 2017 Topical Peer Review Terms of Reference (on Ageing Management) and the Guidance for National Regulatory Organisations - Principles for Openness and Transparency (HLG\_p(2011-14)\_57), ENSREG Working Group 3 has been assigned to prepare a stakeholder engagement plan during the preparatory phase. It is clear for the ENSREG Members that there is a great deal of public interest in the "National Assessment Reports", their outcome and follow up and therefore it is important that the communication regarding the process and its outcome enhances public understanding of the nuclear safety regime and the role of the regulatory authorities. The stakeholder engagement plan identifies activities to strengthen engagement with all stakeholders including the public, industry and governments. Full transparency, but also an opportunity for public involvement, will contribute to the acknowledgment by European citizens of the EU Topical Peer Review process.

#### Actions

- National assessment reports will be published by national regulators on their websites and will be also available through the ENSREG website. Furthermore, participating countries are encouraged to publish relevant parts of assessment reports produced by nuclear licensees. The reports should be made available to the public in accordance with national legislation and international obligations, provided that this does not jeopardize other interests such as, inter alia, security and confidential issues, recognized in national legislation or international obligations.
- Public consultation will be incorporated into the European peer review process, with provision for stakeholders to input questions and comments on national assessment reports via the ENSREG website. Questions may be submitted from 8 January to 28 February 2018. This period of public consultation allows a reasonable time frame for the submission of suggestions, taking into account the overall timetable for the peer review process. Written responses to these questions will be published on the ENSREG website by 30 April 2018. The suggestions will be taken into account globally in preparing the Peer Review Workshop Report as well as the consolidated report to the EU Council.
- The composition of the Peer Review Workshop (President, Vice-presidents, Rapporteurs and Reviewers) will be published as an Annex to the Peer Review Workshop Report. When nominating experts, to participate in the peer review, national regulators should take reasonable steps to ensure the acceptability of the experts to all stakeholder groups (e.g. NGOs, people who took part in the public consultation).
- The outcome of the assessments and any necessary subsequent measures that will be taken should be shared with the Commission and within the ENSREG and should be made public. The presentations will be published on the ENSREG website.

- The Commission, with support by ENSREG, should organize two public meetings for the participation of NGOs' experts and the public, the first one before the peer review workshop (spring 2018) and a second one after the endorsement by ENSREG of the peer review reports (end of 2018). Public meetings on national reports may be organized on a voluntary basis by national regulators and attended, on request, by a representative of the Board of the Peer Review Process.
- Publicity will be given to the peer review workshop through a press release and a press conference that will be arranged on the conclusion of the peer review workshop supported by the ENSREG Chair and the Chair of the Topical Peer Review Board. A press release shall be issued after the completion of the Peer Review final report and, if possible, before the submission of the Commission's report to the European Council.
- Evaluation of the plan (in terms of transparency and stakeholders' involvement achieved) in view of anticipating the next TPR cycle.
